**Explanation of Responses:**

1. On November 26, 2013, the reporting person effected a broker-assisted cashless exercise of 50,000 options. Due to administrative error the Form 4 filed by the reporting person on November 27, 2013 incorrectly reported that 5,400 shares were delivered to the Issuer to pay for the applicable exercise price and withholding tax. This amendment is being filed to reflect the sale of all 50,000 shares acquired pursuant to the option exercise.

2. Price reflected is the weighted-average sale price for shares sold. The shares were sold in multiple transactions, and the range of sale prices for the transactions reported was \$27.00 to \$27.11.
